

SHELL V-POWER CAMPAIGN ON SHELL CARD Terms & Conditions

- The promotion is that Shell Cardholders who successfully consume at least 30 liters of Shell V-Power on their Shell Card between 1st August 2020 to 31st August 2020 ("Qualified Shell Cardholders") might land themselves a free shell fuel card with 100 liters fuel balance already loaded on it ("Free Shell Fuel Card") to be redeemed at Shell Fuel Stations where a Shell Card Machine is located. There will be 5 (five) winning Shell Cardholders selected to receive Free Shell Fuel Card ("the Winners") and there will only be 1 winner from an organization/principal card holder. Additionally, Shell Pakistan Limited ("SPL") will provide credit worth Rs 50,000 (the "Credit Note") to 1 Winner's organization/principal cardholder (the "Winning Organization") by passing a credit note in its Shell Cards invoice. ("Promotion").
- The Free Shell Fuel Card can only be redeemed on Shell Super at any Shell Fuel Station that has a Shell Card Machine.
- The entry for the Promotion is automatic for all Qualified Shell Cardholders; the Shell Cardholder's PAN will be used as entry into the Promotion and for every 30 liters of Shell V-Power consumed on a Shell Card between 1st August 2020 to 31st August 2020 a new entry will be made against the Shell Cardholder's PAN in the Promotion.
- Since the Shell Cardholder's PAN will be used as a basis for entry in the Promotion, if a Shell Card corresponding to a PAN has been lost, misplaced or cancelled for any reason whatsoever, then the consumption of Shell V-Power pertaining to the lost, misplaced or cancelled Shell Card may not be transferred to another Shell Card.
- Winners will be determined by random selection from the pool of Qualified Shell Cardholders by Shell. There can just be 1 Winner from an organization. If the random selection from the pool of Qualified Shell Cardholders results in 2 Shell Cardholder's PANs being selected from 1 organization then only the first Shell Card PAN drawn from the pool will be considered as one of the five Winners.
- Once the 5 Winners have been decided after random selection from the pool of Qualified Shell Cardholders, a second round of random selection will be held to determine which 1 of the 5 organizations will be the Winning Organization and receive the Credit Note worth Rs 50,000 (one time).
- The Credit Note will be passed in the September 2020 Shell Cards invoice of the Winning Organization.
- This Promotion is valid only on selected Shell fuel stations which have a Shell Card Machine and sell Shell V-Power. The redemption of the Free Shell Fuel Cards is also valid only at limited fuel stations which have a Shell Card Machine.
- Shell bears no responsibility of any kind, pertaining but not limited to the use of the Free Shell Fuel Card, once the same have been handed over to the Winners.
- The Winners will be contacted by Shell any time in September 2020 and will also receive their Free Shell Fuel Card in September/October, 2020.
- The decision of Shell regarding all matters pertaining to the Promotion and criteria to select the Winners and the Winning Organization will be final and binding.
- Shell shall not be responsible for any complaints regarding the Shell Card not being able to get swiped or any other fault of the Shell Card Machine or for an unsuccessful Shell Card transaction for any reason whatsoever.
- Shell reserves the right to discontinue this Promotion or to change its terms and conditions at any time and for any reason whatsoever.
- Shell will contact the Winners and the Winning Organization via the registered focal managing the Shell Card account in the organization to hand over the Free Shell Fuel Card. However, Shell will not be held liable in case the registered focal cannot establish contact with the Winners or the Winning Organization for whatsoever reason and for any defect in information provided to Shell by the focal. In such cases where contact cannot be established with the Winners or Winning Organization for whatsoever reason, Shell will conduct

another round of random selection of Qualified Shell Cardholders to determine new Winners and Winning Organization.

- Shell reserves the right to amend, vary, delete or add any of these terms and conditions of this Promotion at any time at its sole discretion without prior notice or liability to anyone. All decisions shall be made solely by Shell in respect of all matters related to or arising out of this Promotion or in the event of any difference or dispute, which decision shall be final, conclusive and binding on all parties concerned.
- In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and other materials relating to or in connection with this Promotion, these terms and conditions shall prevail.
- By participating in this Promotion, all Shell Cardholders agree to be bound by these terms and conditions.
