

## SHELL V-POWER CAMPAIGN ON SHELL CARD

### Terms & Conditions

- The promotion is that Shell Cardholders who successfully consume at least 30 liters of Shell V-Power on their Shell Card between 1<sup>st</sup> February 2020 to 29<sup>th</sup> February 2020 ("Qualified Shell Cardholders") might land themselves an Apple iPad Mini (the "iPad Mini") or a Premium Oil Change (4L SKU) Voucher (the "Oil Change Voucher") to be redeemed at selected Shell Fuel Stations. There will be 2 (two) winning Shell Cardholders selected to receive an iPad Mini and 10 (ten) winning Shell Cardholders selected to receive a Premium Oil Change (4L SKU) Voucher ("the Winners"). Additionally, Shell Pakistan Limited ("Shell") will provide 3 Shell Cards with prepaid balance of Rs 12,500 each to the organizations of the Apple iPad Mini winners, which are then to be distributed to the organization's employees at the organization's discretion. (the "Promotion").
- The entry for the Promotion is automatic for all Qualified Shell Cardholders; the Shell Cardholder's PAN will be used as entry into the Promotion and for every 30 liters of Shell V-Power consumed on a Shell Card between 1<sup>st</sup> February 2020 to 29<sup>th</sup> February 2020 a new entry will be made against the Shell Cardholder's PAN in the Promotion.
- Since the Shell Cardholder's PAN will be used as a basis for entry in the Promotion, if a Shell Card corresponding to a PAN has been lost, misplaced or cancelled for any reason whatsoever, then the consumption of Shell V-Power pertaining to the lost, misplaced or cancelled Shell Card may not be transferred to another Shell Card.
- Winners will be determined by random selection from the pool of Qualified Shell Cardholders by Shell.
- This Promotion is valid only on selected Shell sites which have a Shell Card Machine and sell Shell V-Power. The redemption of the Oil Change Voucher is also valid only at limited sites with the list of these limited sites being shared to with the Winners of the Oil Change Vouchers once they have been contacted.
- The Winner will either be selected to receive iPad Mini or a Premium Oil Change (4L SKU) Voucher and will not be selected to receive both.
- Shell bears no responsibility of any kind, pertaining but not limited to the use of the 3 Shell Cards, once the same have been handed over to the organization of the Apple iPad Mini Winner.
- Winners for either the Apple iPad Mini or the Oil Change Voucher will be contacted by Shell within the first two weeks of March 2020.

- Shell shall not be responsible for any complaints regarding the Shell Card not being able to get swiped or any other fault of the Shell Card Machine or for an unsuccessful Shell Card transaction for any reason whatsoever.

- Shell will contact the iPad Mini Winners via the registered focal managing the Shell Card account in the organization to hand over the iPad Mini. However, Shell will not be held liable in case the registered focal cannot establish contact with the iPad Mini Winner for whatsoever reason and for any defect in information provided to Shell by the focal. In such cases where contact cannot be established with the Winner for whatsoever reason, Shell will conduct another round of random selection of Qualified Shell Cardholders to determine the iPad Mini Winner.
- Shell will contact the Oil Change Voucher Winner via the registered focal managing the Shell Card account in the organization to hand over the same. However, Shell will not be held liable in case the registered focal cannot establish contact with the Oil Change Voucher Winner for whatsoever reason or for any defect in information provided to Shell by the focal. In such cases where contact cannot be established with the Oil Change Voucher Winner for whatsoever reason, Shell will conduct another round of random selection of Qualified Shell Cardholders to determine the Oil Change Voucher Winner.
